1. Specific Objectives

- Complete the University's internal quality assurance system.
- Academic programs are designed and implemented to meet international standards.
- Improve the quality of teaching and learning to achieve the learning outcomes.
- Conduct quality assessment and accreditation at institutional and program levels according to international standards

2. Measures and Action Plans

2.1. Complete the University's internal quality assurance system

- Continue reviewing the internal quality assurance system, focusing on compliance with quality assurance activities across divisions. Operate University activities according to the PDCA cycle, enhancing inspection, supervision, and improvement.
- Increase awareness of quality assurance among the leadership team and faculty, and gradually build a quality culture so that each individual performs their duties effectively towards the University's common goals.
- Promote digital transformation in quality assurance by digitizing evidence and core data to ensure consistency, updates, and accuracy for swift decision-making.
- Enhance the quality assurance capacity of specialized staff and all University personnel.
- Strengthen channels for collecting feedback on service quality, academic programs, and teaching and learning quality to drive improvements.
- Review and complete the system of administrative documents, rules, regulations, and implementation instructions to ensure systematic, strict, and clear execution of work.

2.2. Academic programs are designed and implemented to meet international standards

- Develop new academic programs based on a competency and integration approach relevant to each industry field to meet international standards.
 - Periodically review and update academic programs and course outlines.

2.3. Improve the quality of teaching and learning to achieve the learning outcomes

- Enhance teaching methods.
- Improve assessment and evaluation methods.
- Increase soft skills and English proficiency for students.

2.4. Conduct quality assessment and accreditation at institutional and program levels according to international standards

- Conduct external assessment or accreditation at the program level, aiming for at least 80% of programs to be successfully assessed or accredited by 2025.
 - Implement institutional accreditation (cycle 2) according to international standards.
